Consumer Success Story

Tary has a physical disability and **V** ★ has difficulty accessing her home. She has had 5 hip surgeries and is awaiting a total hip replacement. Mary uses a walker and her home had settled a great deal. She had concrete blocks on top of the highest step (due to the settling) and she was unable to make the huge step into the home. Trying to balance her walker on the steps and the concrete blocks was an accident waiting to happen.

Mary contacted RCIL in the Emporia office and started working with Independent Living Specialist Ellana by devel-

oping a plan on what steps to take to get a ramp built. Mary is a very bright lady who wanted to be totally involved in her plan. Picture of Mary's ramp. She learned how to

complete a Build a Ramp Program application from Ellana. She overcame her barriers to secure two bids from very busy contractors to submit her application. During that process, Mary was persistent in her plan. Since she rents her home, she worked with her landlord to receive input and to choose a contractor.

They chose a contractor not only based on his bid, but received good first impression, answered their questions, and when the project could be started. Mary also applied for additional funding from United Cerebral Palsy and Independence Inc. Seven months later when Mary developed her plan, her three applications were approved and she had her ramp built.

At the conclusion of the project Ellana asked Mary what she had learned. Mary said that "I didn't realize it would be such an extended project and all the hoops we would have to jump through.

> There was a lot of paperwork but it has been totally worth it and the ramp helps me tremendously. I have also had my eyes dilated, had two cataract surgeries and the ramp

has been great. It allows me to go out more and I feel so much safer and independent. I am still waiting on my second hip replacement and I'm on the surgery schedule for later this year. After the surgery I am confident I can return home and continue to access my home safely."



Notice Regarding Direct Deposit and Holiday Payroll for your Direct Service Workers

With the holiday season fast approaching, the RCIL Financial Management Services (FMS) Department would like you, the consumer/employer, to inform your Direct Service Workers (DSWs) of the advantages of using Direct Deposit for their wage payments.

Wages that are paid by Direct Deposit are automatically transferred to the DSW's account on Fridays (unless it is a bank holiday and the

transfer occurs on the day before the holiday). Wages that are paid with a paper check are mailed on Fridays (unless it is a U.S. Postal Service holiday). Once

the paychecks are mailed, RCIL has no control over when the U.S. Postal Service will deliver your DSWs check. The volume of mail that is processed by the U.S. Postal Service usually increases dramatically over the holiday season which sometimes results in even longer processing and delivery of your DSWs check.

RCIL will be making a policy change that requires all Direct Service Workers to sign up for and use Direct Deposit before February 1, 2017. We will no longer offer wage payment by check after February 1, 2017.

Please inform your Direct Service Worker of this important policy change and encourage them to consider enrolling in a Direct Deposit

option now to avoid any frustration on their part by a paycheck being delayed in the mail over the holiday season. The bank holidays this year in December and January do not interfere with the normal Friday Direct Deposits. However, the U.S. Postal Service will also be observing the holidays and will have additional

days when the mail is not delivered (Monday, December 26, 2016 and Monday, January 2, 2017).

RCIL has a Global Cash Card option or your DSW can choose to use their personal checking or savings account or another bank card that has their name, routing number and account number.

terpreters, large print or Braille materials, and other accommodations will be provided to those students who request them.



- With at least one resident who participates in the U.S. Supplemental Nutrition Assistance Program (SNAP) and
- With an address in AT&T's service area in Kansas where they offer wireline home Internet service, and
- Without outstanding debt for AT&T fixed Internet service within the last six months or outstanding debt incurred under this program.

If you qualify, the service availability and speed may vary by address. AT&T will assign you the fastest of these speed tiers available where you live:



- 5 megabits per second, for \$10 per month
- 3 megabits per second, for \$5 per month

If none of the above speeds are technically available at your address, unfortunately you won't be able to participate in the Access program from AT&T at this time. However, please continue to check back with AT&T because they are updating their systems so that lower speed tiers can qualify in the future.

Are you interested and want to apply? Call an AT&T representative at 1-855-220-5211 to request an application. If you need assistance to complete the application, contact your local RCIL office and an Independent Living Specialist will assist you.



What is LIEAP?

Low Income Energy Assistance Program (LIEAP) is a federally funded program which helps qualifying households to pay their home heating and cooling energy costs. LIEAP applications are available at your local Department for Children and Families (DCF) office from midJanuary through the end of March 2017.

When do I file my Homestead Refund?

The deadline to file homestead refund is April 18, 2017. The homestead refund is based on a portion of the property tax paid on a Kansas resident's home and the maximum refund is \$700. To qualify for homestead refund, you must be a Kansas resident and living in Kansas the entire year. Also, your total household income must be \$34,000 or less.
